- ❑ The NTBA Member Relations Manager will visit stores for proactive and reactive calls for various reasons.

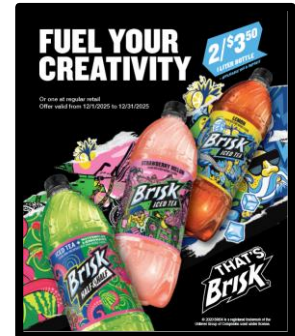

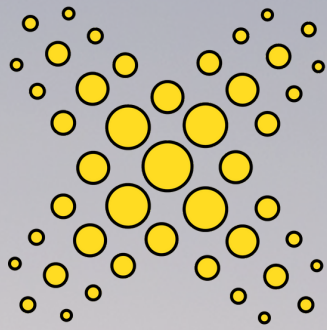

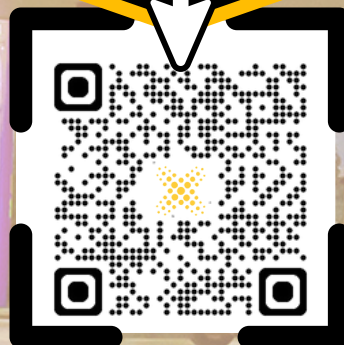
