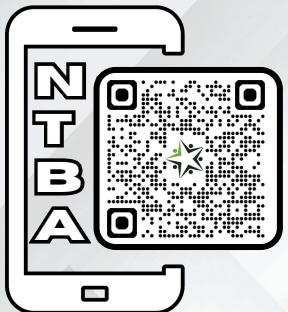

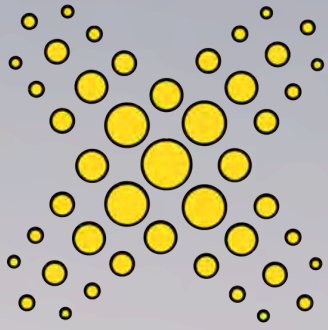

TEXAS RIGHTS FOR WORKERS

Share Your Rights: Workplace Discrimination is Illegal

Under the Texas Workforce Commission's Equal Employment Opportunity Act, it is illegal for an employer to discriminate against an employee on the basis of race, color, sex, religion, national origin, age, or disability.

What is illegal:

- Refusing to hire or promote someone because of their race, color, sex, religion, national origin, age, or disability.
- Paying someone less than others for the same job because of their race, color, sex, religion, national origin, age, or disability.
- Forcing someone to work under different conditions than others because of their race, color, sex, religion, national origin, age, or disability.
- Retaliating against someone for reporting discrimination.

What is not illegal:

- Discriminating against someone based on their physical appearance, height, weight, or marital status.
- Discriminating against someone based on their criminal record.
- Discriminating against someone based on their credit history.
- Discriminating against someone based on their sexual orientation.

Texas Workforce Commission
ATTENTION EMPLOYEES

Employees who are covered by the Texas Workforce Commission's Equal Employment Opportunity Act have the right to a safe and healthy workplace. If you believe your employer is violating these rights, you should report the violation to the Texas Workforce Commission.

What is illegal:

- Violating OSHA safety and health standards.
- Violating the Texas Workforce Commission's Equal Employment Opportunity Act.

What to do:

- Report the violation to the Texas Workforce Commission.

NOTICE TO EMPLOYEES COVERED BY A SALARY OR PAY PLAN UNDER THE WORKERS' COMPENSATION ACT FROM THE OFFICE OF PUBLIC EMPLOYMENT

Employees who are covered by a salary or pay plan under the Workers' Compensation Act from the Office of Public Employment have the right to a safe and healthy workplace. If you believe your employer is violating these rights, you should report the violation to the Texas Workforce Commission.

What is illegal:

- Violating OSHA safety and health standards.
- Violating the Texas Workforce Commission's Equal Employment Opportunity Act.

What to do:

- Report the violation to the Texas Workforce Commission.
- File a complaint with the Texas Workforce Commission.
- Cooperate with the Texas Workforce Commission's investigation.

Your Employee Rights Under the Family and Medical Leave Act

What is FMLA?

The Family and Medical Leave Act (FMLA) allows eligible employees to take unpaid, job-protected leave for certain family and medical reasons.

What does my employer need to do?

- Provide notice of FMLA to employees.
- Provide information about FMLA to employees.
- Allow employees to take FMLA leave.
- Restore employees to their original or equivalent position.

Am I eligible to take FMLA leave?

- Work for a covered employer.
- Work full-time for the employer.
- Work for the employer for at least 12 months.
- Work at least 1,250 hours for the employer.

Where can I find more information?

Visit the Texas Workforce Commission's website at www.twc.state.tx.us.

How do I request FMLA leave?

Notify your employer in writing of your intent to take FMLA leave.

CHILDLABOR LAW

The Texas Workforce Commission's Child Labor Law prohibits employers from employing children and minors in hazardous occupations.

What is illegal:

- Employing children and minors in hazardous occupations.
- Employing children and minors in occupations that require the use of tools, machinery, or equipment.
- Employing children and minors in occupations that require the use of heavy lifting.

What to do:

- Report the violation to the Texas Workforce Commission.
- File a complaint with the Texas Workforce Commission.
- Cooperate with the Texas Workforce Commission's investigation.

YOUR RIGHTS UNDER USERRA
THE UNIFORMED SERVICES EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT

USERRA protects the job rights of individuals who are called to active military service. It requires employers to reemploy service members and veterans who leave their civilian jobs to serve in the military.

What is illegal:

- Denying a service member or veteran reemployment rights.
- Discriminating against a service member or veteran because of their military service.

What to do:

- Report the violation to the Texas Workforce Commission.
- File a complaint with the Texas Workforce Commission.
- Cooperate with the Texas Workforce Commission's investigation.

THE LAW IN TEXAS

The Texas Workforce Commission's Equal Employment Opportunity Act prohibits employers from discriminating against employees on the basis of race, color, sex, religion, national origin, age, or disability.

What is illegal:

- Discriminating against employees on the basis of race, color, sex, religion, national origin, age, or disability.

What to do:

- Report the violation to the Texas Workforce Commission.
- File a complaint with the Texas Workforce Commission.
- Cooperate with the Texas Workforce Commission's investigation.

ATTENTION EMPLOYEES

EMPLOYEE RIGHTS UNDER THE FAIR LABOR STANDARDS ACT

FEDERAL MINIMUM WAGE

\$7.25 per hour

The law requires employers to pay the federal minimum wage to all employees who are covered by the law.

OTHER RIGHTS:

- CHILD LABOR:** Employers are prohibited from employing children and minors in hazardous occupations.
- TP OMBEST:** Employees have the right to a safe and healthy workplace.
- EMPLOYMENT:** Employees have the right to a safe and healthy workplace.

EMPLOYEE RIGHTS
EMPLOYEE POLYGRAPH PROTECTION ACT

The Employee Polygraph Protection Act prohibits most private employers from using lie detector tests either for pre-employment screening or during the course of employment.

PROHIBITION: Employees are generally prohibited from being subjected to a lie detector test.

EXEMPTIONS: There are certain exemptions to the Act, including:

- Employers who are required to use lie detector tests by state or federal law.
- Employers who are required to use lie detector tests by a court order.
- Employers who are required to use lie detector tests by a contract.
